ARTS, CRAFTS & FOOD BOOTH RENTAL RULES & ENTRY FORM

1. ENTRY FEES FOR BOOTHS MUST ACCOMPANY ENTRY FORM TO RESERVE A SPACE.
2. MAKE CHECK PAYABLE TO: CHAMBER OF COMMERCE – MAIL OR BRING BY CHAMBER OFFICE NO LATER THAN DECEMBER 1, 2009. THERE WILL BE A \$10.00 LATE FEE FOR RESERVATIONS MADE AFTER THIS DATE.
3. BOOTHS ARE ASSIGNED AS WE RECEIVE THEM, FIRST COME FIRST SERVED. **Numbers will be assigned 1 to 2 days before, at that time you will receive a phone call informing you of your booth number.**
4. NO REFUNDS ARE ALLOWED ON BOOTH ENTRY FEES- NO EXCEPTIONS!
5. EACH ENTRY MUST BE APPROVED BY THE COMMITTEE. THIS IS A FAMILY ORIENTED FESTIVAL, AND IF THE COMMITTEE DENIES YOUR ENTRY YOU WILL BE NOTIFIED.
6. BOOTH SIZES ARE 10 X 10. THE COST IS \$25.00. **NO FOOD BOOTHS**
7. EACH ENTRANT IS RESPONSIBLE FOR THEIR OWN BOOTH AREA CLEAN UP, TABLES, CHAIRS, AND ANYTHING ELSE NEEDED TO SET UP YOUR BOOTH. GARBAGE CONTAINERS WILL BE PROVIDED FOR TRASH.
8. BOOTH MUST BE SET UP AND READY FOR BUSINESS BY 4:30PM MONDAY.
9. IF YOU USE A TRAILER FOR YOUR BOOTH – YOU MUST PROVIDE THE DIMENSIONS OF THE TRAILER ON THE ENTRY FORM.
10. PARKING IS NOT ALLOWED ON THE STREETS WHERE THE BOOTHS ARE LOCATED OR ANY STREET THAT IS BLOCKED OFF DUE TO THE FESTIVAL.
11. IF ELECTRICITY IS NEEDED WE MUST KNOW IN ADVANCE—OUTLETS ARE LIMITED.
12. NO SOUND SYSTEM OR BROADCASTING DEVICES OF ANY KIND MAY BE USED WITHOUT PRIOR CONSENT OF THE CHAMBER OF COMMERCE COMMITTEE.
13. COMPLIANCE WITH LAWS—LESSEE, HIS AGENTS, EMPLOYEES OR ASSIGNEES SHALL COMPLY WITH ALL THE RULES, REGULATIONS, AND REQUIREMENTS OF THE CITY, HEALTH DEPT., FIRE MARSHALL, OR ANY GOVERNMENT ENTITY HAVING JURISDICTION OVER THE PREMISES.
14. A DESCRIPTION OF THE MERCHANDISE, ETC. YOU WILL BE SELLING IS REQUIRED.
15. NOT RESPONSIBLE FOR ACCIDENTS OR LOST MERCHANDISE OR ANYTHING LEFT OVERNIGHT, AS SPECIAL SECURITY IS NOT PROVIDED.
